 - o It appears the abbreviated [IRS: 1023-EZ] 'Application for Recognition of 501C3 Exemption' will suffice
 - o (provisionally assumes projected gross cash receipts for first three years will be less than \$50k per year)
 - o User fee with application for the 1023-EZ application is \$275
 - Question whether Library could (or should) receive parallel donations directly was left on the table...
 - ACTION: Ellen will work on completing Application for future review
